Specifically, the amendments gave Canadian citizenship to persons who were born or naturalized in Canada as well as to those who were British subjects ordinarily resident in Canada on January 1, 1947 (April 1, 1949, in the case of Newfoundland and Labrador), but who were not eligible for Canadian citizenship when the Canadian Citizenship Act took effect. The amendments also retroactively gave Canadian citizens on January 1, 1947 (or April 1, 1949), but who did not themselves become Canadian citizens on those dates. On June 19, 2014, the exception to the first generation limit to citizenship by descent was extended to children born outside Canada in or with the Canadian Armed Forces, the federal public administration or the public service of a province or territory, other than as a locally engaged person. Extension to the exceptions to the first generation limit in 2014 The first generation limit on claims of citizenship by descent through a parent does not apply to a person born outside Canada in the second or subsequent generation if: the person is born to a Crown servant, or at the time of their parent's birth or adoption, the person's grandparent was employed outside Canadian Armed Forces, the federal public administration or public service of a province or territory, other than as a locally engaged person (a crown servant).
